**No late arrivals.** Entry fee must be received at the address below by the Thursday before the tournament in order to draw for boat starting position. There is a \$10 late entrance fee for signing up on the day of the event.

**ENTRY FEE - \$110** per team & includes 1<sup>st</sup> Lunker & 2<sup>nd</sup> place Lunker. Pay out of 70% remaining 30% will be allocated to the Points Championship and expenses. Cash prizes will be awarded to the top **20%** of the field. As an example, 50 team field will pay out:

**1<sup>st</sup> - \$710 2<sup>nd</sup> - \$525 3<sup>rd</sup> - \$450 4<sup>th</sup> - \$350 5<sup>th</sup> - \$300 6<sup>th</sup> - \$250 7<sup>th</sup> - \$200 8<sup>th</sup> - \$150 9<sup>th</sup> - \$120 10<sup>th</sup> - \$100**

**OPTIONAL POOL - \$70** per team. 100% Payout of optional Pool. (Optional pool pays out 20% of the field)

**RULES:** For full set of rules, please refer to the “Bylaws” located on [www.srtt.bigbass.com](http://www.srtt.bigbass.com)  
 The following rules are only a digest of the bylaws. It is the responsibility of the team to read & understand all rules associated.  
 5 BASS limit, 15" minimum length. Exceptions: 3 Bass 18" minimum in Big Bass Waters during Spring, 5 bass, 12" limit out of big bass waters during regular bass season.

Smallmouth and Largemouth Bass only.  
 Artificial lures only. No live bait. No trolling.  
 Only 1 rod may be used per contestant at one time.  
 No Culling of Dead or Distressed Fish. 8 ounce penalty per dead fish.

**Disqualification for all: short fish or culling of dead or distressed fish.**  
 All PA Fish Commission laws apply.  
 PERSONAL FLOTATION DEVICES must be worn while gasoline engine is running.  
 Bass must be kept alive in an **aerated live-well**. The SRTT **requires** a two pump system.  
 The SRTT Board of Directors has final decision on ALL issues.

Upon start of tournament, you must stay in your boat except for an emergency.  
 Legal fish measured from tip of mouth (mouth closed) to tip of longest point on the tail. PA Fish Commission Rule Applies.  
 The tournament will be rescheduled if the predicted river stage for the day of the tournament is greater than 10 feet (HBG stage) as reported by the National Weather Service on the day preceding the tournament. The river forecast phone # is (888) 881-7555. Check the SRTT website - [www.srtt.bigbass.com](http://www.srtt.bigbass.com) for up-to-date information and new schedule. You may choose to withdraw after a new date has been established.

**Boat Owner Must Carry a Minimum Liability Insurance Policy of \$100,000.**
